RT4 July 20th, 2020 Board Meeting Notes In Attendance: AM, EQ, KD, RM, DB, TC

— Welcome

- GitLab Discussion of policing platform

KD will send out registration details and instructions again for the GitLab repository, and details for the Friday call. All board members will be expected to (a) register with GitLab, (b) review the police reforms, and (c) participate in a one-hour collaborative meeting to finalize the list of police reforms RT4 will endorse, at 12pm Eastern on Friday.

...

— Findings from BlueLeaks materials

RT4 mentioned in passing via reddit link

TC and KD will collaborate on further searching of leaks for useful materials on fusion centers and policing relevant to the list of endorsed police reforms.

- Budget discussions in view of new \$25k DuckDuckGo donation

TC will circulate a budget that includes spending on 2 U2F Security Keys per board member and increased funding for Khulani

DB confirms that \$1500 for ads is adequate for the moment

— Board diversification, focusing on Muslim women of color

DB emphasizes importance of participation on board by low-income people and of carefully wording calls for board diversification so as not to reduce political diversity.

AM notes that in a prior nonprofit he ran, there was a 25% requirement that board members be low-income. EQ and KD note that they may already qualify.

RM explains ways that women board members can bring specific perspectives on surveillance, relating to stalking and domestic violence.

Zaki Manian is reported by RM to have an interest in returning to the board.

AM should schedule a new call for RT4 activists potentially interested in board membership. All board members will send to AM by 7/28/20 two suggestions for new, potentially qualified board

members.

- Creating recruitment video for RT4

EQ notes that universities like Bucknell near him, often collaborate with local nonprofits to produce promotional videos. AM notes that Brandeis does something similar. AM will put out call to RT4 list for potential videographers

— Whether to continue involvement in "Coalition Against Rider Surveillance" in view of Uber backing AM recuses himself from vote because of possible conflict of interest

Motion by DB to direct AM to examine CARS' governance structure and funding, and on that basis to decide whether to pull us out of CARS coalition; and that future decisions on joining coalitions should similarly not be taken without having an adequate understanding of governance structure and funding, with particular attention to whether a single non-civil-liberties-org entity is providing exclusive funding. Seconded by TC. Passed unanimously.

- Next steps on PATRIOT Act fight

- RT4 joined Demand Progress/FFTF petition campaign to remind constituents that 215 vote may come up again at any time. Pelosi/McConnell attempts to revive it may come in the fall, after the November election, or opportunistically after a terrorist attack.

New business

- Portland: Oregon barred attorneys needed, AM reaching out to PDX Privacy. Board generally in agreement that participating in litigation on this issue is important. Final decision to take place by email vote after AM has identified attorney to work with.

- MA S2820 qualified immunity bill: House version effectively strips qualified immunity reforms. AM already using RT4 national list for MA to push calls for strong bill.
