----- Coalition letters reacting to Capitol insurrection (no expansion to domestic surveillance, no renewal of PATRIOT Act powers, no domestic terrorism statute)

----- AM helped draft the CDT letter. He will circulate these newly signed coalition letters after the board meeting.

----- Update on Snowden pardon work

------ Around 2,000 communications sent to White House to help with a pardon. Came down to the wire, appears to have failed thanks to Republican Senators threatening Trump with post-impeachment votes to convict him, if he pardoned Snowden or Assange.

------ Biden administration: Not likely to pardon Ulbricht or Snowden. Slightly more likely that they will pardon Assange given approach of Obama admin to the case. Much more likely to pardon Winner and Albury. LegWG not yet considering pardons advocacy for this administration.

----- Mass surveillance and US Marshals

----- Collaborative petition work with DRAD and Demand Progress preparing for launch of 4A Is Not For Sale Act
